## NOTICE

Pursuant to the issuance of the letter dated 30.11.2021 by the Assistant Registrar (AG) Supreme Court of India vide letter No. GSICC/2019/SC(AG), the consent(s) of the undersigned were taken to carry out the election of one female member from Supreme Court Advocate on Record Association for the purposes of representation at gender sensitisation and internal complaints committee of the Supreme Court of India in terms rule 4(2)(d) of The Gender Sensitisation And Sexual Harassment Of Women At Supreme Court Of India (Prevention, Prohibition & Redressal) Regulations, 2013. Accordingly, a unanimous resolution was passed by the Executive Committee of SCAORA On 07.12.2021 and a request was made to this election committee to conduct the election for the aforementioned purpose, as the term of 2 years of Ms. Abha Sharma who was nominated member of The Supreme Court Gender Sensitisation & Internal Complaints Committee (GSICC) for a term of 2 years is going to end of 06.01.2022. The election for the aforesaid purpose will be held by way of physical voting.

1. Election for electing one member of Gender Sensitisation & Internal Complaints Committee (GSICC), As representative of SCAORA under rule 4(2)(d) of The Gender Sensitisation And Sexual Harassment Of Women At Supreme Court Of India (Prevention, Prohibition & Redressal) Regulations, 2013 will be conducted through secret ballot on 16.12.2021
2. Qualification of Candidates: Member must be registered with SCAORA
3. Every member can cast their ballot to give maximum of 1 preference only out of the contestants.
4. The candidates who get the highest number of votes in terms of rule 4(2)(d) would be declared elected
5. In case only a single nomination is received till the last date of filing of nomination, such candidate shall be elected unopposed and there shall be no casting of ballot thereafter.

  - 1) Filing of nomination: 09.12.2021 to 13.12.2021 of 2021 from 10:30 AM till 4:30 PM at SCAORA office in the office of Supreme Court Advocate on Record Association.
  - 2) Declaration of tentative list of candidates: 13.12.2021 at 5:30 PM.
